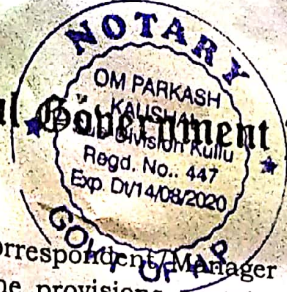

7. That the Principal and Correspondent/Manager of the school have individually gone through the provisions contained in the affiliation & examination byelaws and he circulars issued by the Board from time to time. The school undertakes to abide by the provisions contained in the affiliation & bylaws, directions issued from time to time and the law of the land.
